Contributions to Robert Antonellis for U.S. Senate are not tax-deductible as charitable contributions for federal income tax purposes. Contributions are limited to \$6,600 per individual per two year election cycle (\$3,300 primary election, \$3,300 general election), \$13,200 for couples, per two-year election cycle. Federal law requires us to collect and report the name, mailing address, occupation, and name of employer of individuals whose contributions exceed \$200 in a calendar year. Contributions by corporations and foreign nationals are prohibited.
