

PRIVACY POLICY

Effective Date: June 5th, 2023

This Privacy Policy outlines how the Bob for Senate Campaign "Campaign" collects, uses, and shares your information when you use our websites, mobile sites, and mobile application (referred to as the "Site"). We may update this policy periodically, and we will notify you of any changes by updating the date at the top of the policy. It is recommended that you review the Privacy Policy regularly to stay informed about our information practices and available choices.

PLEASE READ OUR PRIVACY POLICY CAREFULLY TO GET A CLEAR UNDERSTANDING OF HOW WE COLLECT, USE, PROTECT OR OTHERWISE HANDLE YOUR PERSONAL INFORMATION IN ACCORDANCE WITH THE LAW. BY USING THIS WEBSITE, YOU EXPRESSLY ACKNOWLEDGE AND AGREE TO OUR COLLECTION, USE, SHARING, AND PROTECTION OF YOUR PERSONAL INFORMATION AS SUMMARIZED BELOW AND AS FULLY DESCRIBED IN OUR USER PRIVACY NOTICE.

- 1) **Statements made.** Please note that political websites and campaigns may have distinct requirements as per the Federal Election Campaign Act. Statements made on this website may not reflect the actual opinion of U.S. Senate candidate contender Robert Antonellis [R-MA]. Any statements made regarding opposing candidates, including references to "QEW" or "Queen Elizabeth Warren", are intended solely as satire and should not be used for legal purposes. These satirical comments do not represent the candidate's true views or beliefs.
- 2) **Government Contribution Limits.** Individual contribution limits are set at \$3,300 per election. Your contribution, up to \$3,300, will be allocated for the primary election, while the next \$3,300 will be designated for the general election. In accordance with federal law, we are obligated to make every effort to collect and disclose the name, address, occupation, and employer of individuals whose contribution exceeds \$200 in an election cycle.
- 3) **Changes.** From time to time, we may use your information for new, unanticipated uses not previously disclosed in our privacy policy. If our information practices change materially at some time in the future, we will post an updated policy to our Website.
- 4) **Collection Of Information.** Categories of Personal Information We Collect. Personally Identifiable Information is information that identifies a specific person. When you engage in certain activities via the Campaign, including but not limited to creating an account, sending feedback, or otherwise participating in the Campaign (collectively, "Identification Activities"), we will ask you to provide certain information about yourself. We also collect the following:
 - i) Identity Data;
 - ii) Contact Data;
 - iii) Technical Data;
 - iv) Usage Data;

v) Location Data;

- b) If you elect to engage in an Identification Activity we will ask you to provide us with certain personal information about yourself, such as your name, address (including zip code), email address, telephone number and/or any other information you provide to us, to process your transaction, send communications about them to you, and populate forms for future transactions.

5) Information You Provide to Us.

- a) As required by the Federal Election Commission (FEC), we may collect certain personal information from donors, including their name, mailing address, occupation, and employer, for donations exceeding \$200 per election cycle.
- b) We collect information directly from you when you engage with us, such as signing up for updates, requesting information, filling out forms, signing petitions, volunteering, registering for events, creating an account, participating in contests or promotions, making donations or purchases, contacting us through social media, seeking support, sending emails, or any other form of communication. The information we may collect includes your name, email address, postal address, phone number, payment details (collected by a third-party processor), and any other information you choose to share.

- 6) Information We Collect from Other Sources.** We and our Campaign providers may gather information about you from external sources and combine it with the data we collect on our Site. This includes obtaining information from third parties and accessing certain details from your social media account (such as name, account information, and friends lists) if you log in or create an account through a social media site, based on your privacy settings and the site's privacy policy.

7) How We Use Your Information.

- a) When you register, contribute, sign up to volunteer, or take any other action on our site, we may ask you to give us contact information, including your name, address, telephone number and/or e-mail address. We may obtain information about you from outside sources and add it to or combine it with the information we collect through this site. We use this information to operate this site, send you news and information to you about Bob for Senate & to solicit your participation in Bob for Senate programs, events and activities, and obtain and confirm RSVP's to events and programs. We use your e-mail address to send such information by e-mail and may use your telephone number to call you for these purposes.
- b) We will never provide your e-mail address or any of your personal information to any other person or organization, for any purpose. If you decide to purchase tickets to an event or to make a contribution online, we may also ask for your credit card number and its expiration date. That information is used solely for processing your contribution; is not maintained by our organization; and is never disclosed to anyone, for any other purpose other than for processing your contribution, under any circumstances.

- 8) **Sharing Of Information.** We may share your information in the following ways:
- a) With your consent or at your direction;
 - b) With candidates, organizations, campaigns, or groups that share similar political viewpoints, principles, objectives, or goals, as well as organizations that facilitate communication and information sharing among such groups, provided they agree to protect the information as stated in this Privacy Policy;
 - c) To report necessary information to the Federal Elections Commission, including the names, addresses, occupations, and employers of individuals whose contributions to the Campaign exceed \$200 in an election cycle (for more details, refer to the FEC website at <https://www.fec.gov>);
 - d) With vendors, service providers, volunteers, and consultants who require access to the information to perform tasks on our behalf;
 - e) In response to a lawful request or legal process, such as requests from public authorities for national security or law enforcement purposes, or if we believe disclosure is necessary to comply with applicable laws or legal obligations;
 - f) If we believe your actions are inconsistent with our user agreements or policies, or to protect the rights, property, and safety of the Campaign, its employees, volunteers, constituents, or others, and;
 - g) In connection with reorganization, formation of new committees, asset sales or transfers, financing or lending transactions, or any other situation where personal information may be disclosed or transferred as one of the Campaign's assets, with appropriate safeguards.
- 9) **Social Features.** The Site may include social sharing features and integrated tools (like the Facebook "Like" button) that allow you to share your actions on our Site with other media, and vice versa. Your use of these features may result in the sharing of information with your friends or the public, depending on your privacy settings on the relevant social media site. For more information on data collection and processing related to social sharing features, please refer to the privacy policies of the entities providing these features.
- 10) **How We Protect Information You Provide.** Bob for Senate uses industry standard security measures to protect against the loss, misuse or alteration of the information under our control. Our server is located in a locked, secure environment. Permission to access your information is granted only to you and Bob for Senate employees or contractors who need to know that information to provide to you. Although we make good faith efforts to store information collected by this website in a secure operating environment, we cannot guarantee complete security.
- 11) **Transfer of Information.** As a Massachusetts based campaign directed towards U.S. residents, we process and store information within the United States. If you are located outside the U.S., please be aware that your information may be transferred to or stored in jurisdictions that may not offer the same level of data protection as your home jurisdiction.

- 12) **Links to Other Websites.** This privacy policy covers this website and its subdomains. These sites may link to third-party websites. We are not responsible for the content or privacy policies of these third-party sites. We encourage you to read the privacy policies and review the practices of all websites you visit.
- 13) **Other Disclosure of Your Information.** Though we make every effort to preserve user privacy, we may need to disclose personal information when we have a good-faith belief release is appropriate to comply with the law (for example, a lawful subpoena), to protect our rights or property, or to protect our donors, artists and supporters from fraudulent, abusive, or unlawful conduct, or if we reasonably believe that an emergency involving immediate danger of death or serious physical injury to any person requires disclosure of communications or justifies disclosure of records without delay.
- 14) **Children's Policy.** We want to help you guard your children's privacy. We encourage you to talk to your children about safe and responsible use of their personal information while using the Internet. Bob for Senate does not knowingly collect, use or distribute children's personally identifiable information to any third parties. If you have any reservations, questions or concerns about your child's access to this site or how information that your child provides is used by us, please contact us.
- 15) **Cookies, IP Addresses and Log File Data Cookies.**
- a) A cookie is a piece of data stored on the user's hard drive containing information about the user.
 - b) Bob for Senate website uses a cookie for measuring aggregate web statistics, including number of monthly visitors, number of repeat visitors, most popular webpages and other information. Bob for Senate will also use cookies to facilitate your online visit by maintaining data that you provide for online activism activities so that you will not need to resubmit certain information.
 - c) We may also use third-party services such as Google Analytics. This helps us understand traffic patterns and know if there are problems with our Site. We may also use embedded images in emails to track open rates for our mailings, so that we can tell which mailings appeal most to our supporters.
- 16) **Advertising.** We may place online advertising with third-party vendors, including Google, which will be shown on other Sites on the Internet. In some cases, those third-party vendors may decide which ads to show you based on your prior visits to the Site. At no time will you be personally identified to those third-party vendors, nor will any of the information you share with us be shared with those third-party vendors. If you prefer to opt out of the use of these third-party cookies on the Site, you can do so by emailing us.
- 17) **Server Log Files.** We log standard technical information, such as your IP address and the kind of browser you use. We log this information for troubleshooting purposes and to track which pages people visit in order to improve the site. We do not use log files to track a particular individual's use of the website.
- 18) **How to Unsubscribe or Opt Out.** People who subscribe to e-mail lists via this website will receive periodic updates from Bob for Senate by regular mail, fax and/or e-mail.
